This brief article on Chris Renwick's Bread for All outlines the ways in which an ideology of blaming the victim perpetuated a mindset that institutionalized poverty in the UK and Ireland. This was not to change until there was a shift in the popular mindset, driven in large measure by the struggles against destitution waged by the poor, particularly in the French Revolution, and the rise of the Labour Party as a consequence. This analysis of how the welfare state emerged echoes the case made by Francois Furstenberg in his article, "What History Teaches Us About the Welfare State."

Gamble's piece presents a very useful retrospective on the rise and evolution of the welfare state and the interplay of conflicting ideologies and political interests that have shaped its challenges for legitimacy and survival. Particularly interesting is Gamble's observation that the richer and more consumerist societies become, the less willing they are to accept the costs associated with maintaining programs in service to collective social aims. His discussion of the intellectual battles that have shaped the policy wars is also a valuable index of the worldviews and assumptions governing the key force at play, including those advocating the politics of austerity as the appropriate response to the current, and ongoing, economic crisis.
